Vancouver Island Regional Library (vi) Councillor Vomacka reported that at the Annual General Meeting and Trustees meeting held on Saturday, January 30<sup>th</sup>, 2021 Mayor of Port McNeill, Gaby Wickstrom was named Chair.

She further reported that 12,000 new members had registered since the start of the pandemic and that the Library's social media had had 1.4 million visits in 2020.

Councillor Vomacka reported that the Town of Lake Cowichans Library would be having remedial flooring work done in 2021.

Advisory Planning Commission

(vii) Councillor Austin reported that at the Advisory Planning Commission meeting held on January 28<sup>th</sup>, 2021 Darlene Ector was elected Chair. New members Lynn Klein and Janice New were welcomed. She also reported that the Zoning Bylaw is almost ready to be presented to Council. She reported that there would be a zoom open house in the future regarding the Active Transportation Plan. The next meeting will be held February 25<sup>th</sup>, 2021.

# Cowichan Valley Regional District

(i) Councillor McGonigle gave a verbal report on the meetings held for the Special Corporate Services and the CVRD Budget discussions. He noted that Schedule" E" reflects the impact to the Town of Lake Cowichan and the public can access the budget on the Regional District's website. Lake Cowichan is facing a 2.56% increase in the Regional District tax requisition.

A meeting will be held February 24<sup>th</sup>, 2021 between the CVRD and the Cowichan District Hospital Board.

# Community Outreach Team

(ii) Councillor Austin spoke on the Community Outreach Team meeting that was held on February 18<sup>th</sup>, 2021. She reported that advertising will be displayed when the Covid-19 vaccine clinics are announced. Community Services is currently short of Counsellors, though counselling is available via zoom. The soup kitchen is still operating from Monday to Thursday. There is an increase in new people accessing the free market. Community Services is also offering free tax returns for those in need. The Ministry of Poverty Reduction has been trying to help the homeless in Lake Cowichan, but it is having a hard time connecting with residents in need. She also reported that Fit for Life is occuring at the Cowichan Lake Sports Arena as well as Public skating.

# Cowichan Watershed Board

(iv) Councillor Sandhu reported that the Board held its meeting on February 22<sup>nd</sup>, 2021. Councillor Sandhu reported that new member Linda Higgins, Representative from the Department of Fisheries and Oceans was welcomed. The Board is sending a letter to Mosaic requesting a pause in logging operations near the Koksilah ancient forest. The Annual General Meeting of the Cowichan Watershed Society will be held February 25<sup>th</sup>, 2021. Councillor Sandhu will continue as a member on the Board of Directors for 2021.
