# 8. <u>BYLAWS</u>

#### 9. **NEW BUSINESS**

Our Health - Our Community Survey

Council members discussed the submission of questions for the survey (a) that is being sent out by Our Cowichan Communities Health Network which included the following:

- Access to services not available in Lake Cowichan but only in Duncan:
- Cost of living right now with cost of healthy foods a challenge to consumers;
- Cost of rental housing now requires dual incomes;
- Need to address health and wellness services;
- Access to services transportation for access to medical services in Duncan;
- Outreach supports needed lack of volunteers;
- Survey needs to include gender and ages;
- Services in Duncan require transit and transportation;
- Lack of satellite services at moment with 9 hours per week given for adult counselling services and the health unit does not have the capacity for this as well; and
- The importance of having online appointments for mental health.

The two questions to be forwarded for consideration are as follows:

- 1. If the Town of Lake Cowichan could incorporate a community health centre similar to Ladysmith and Chemainus in our area which has a similar population, what services would you like to see provided? With a list of applicable answers; and
- 2. What would it take to incorporate satellite mental health and addiction services into the community?

No. R.009/23 Emergency Operations Centre (EOC) Grant – Regional Grant 2023 for Operations Centre (b)

that the Cowichan Valley Regional District apply for, receive and manage the Union of BC Municipalities Community Emergency Preparedness Fund for Public Notification and Evacuation Route Planning grant funding up to \$150,000 on behalf of the Town of Lake Cowichan.

(c) Councillor Austin gave a verbal report on the discussions that were had with the parents and youth interested in travelling as delegates to Ohtaki, Japan in July, 2023.

The appointment of the delegation leader for the Ohtaki exchange programme has been deferred to the next Committee of the Whole.

(d) Councillor Frisby gave a verbal report on his attendance as a business owner at the recent Chamber of Commerce business meeting held with representatives of 4VI (formerly Tourism Vancouver Island).

He spoke on the findings of the report and the recommendations outlined. In reference to the tourism coordinator, it was felt that this position should not be held by municipal governments but by Chambers or an outside organization such as themselves. There are no further action items from Council nor any follow-up required with 4VI.

**(e)** Councillor Sandhu requested an update on the AB Greenwell acquisition and was advised that it will be dealt with later.

Mayor McGonigle wanted to clarify that the AB Greenwell property is being demolished by the School District and that the School Board had made application to the Province for capital funding to undertake the demolition of the buildings.

(f) Staff was directed to arrange a community and community meeting between the Town Council and the Ts'uubaa-asatx. A meeting is scheduled for Monday, May 6<sup>th</sup> with time to be determined.

Mayor McGonigle gave a huge shout out to the Lake Cowichan Minor Hockey Association Executive for its recent anniversary event held on the weekend which included an alumni game with former hockey players from the community.

He stated that "Once you are a Laker, you are always a Laker".
