## **ADDENDUM**

The following revisions supersede the information contained in the original drawings and specifications issued for the above-named project to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the contractor or any subcontractor not being familiar with this addendum.

- 1. Information: The Tender Closing has been extended to November 24, 2017 at 2:00pm.
- 2. Question: Is it possible to change the tender form to include a price adder if only one crossing is awarded?

Answer: As noted in Addendum #1, the Town of Lake Cowichan reserves the right to award either portion of the project (Greendale or Ohtaki) without awarding the other. In consideration of the fact that the cost of General Conditions would be affected by splitting the projects, a line has been added to the Summary Sheet to provide a "General Requirements Premium for Partial Award". For evaluation purposes, this amount will be added to the Tender Price for the Greendale Trestle or the Ohtaki Footbridge, in the event of a partial award.
